ADMINISTRATIVE ORDER MUNICIPAL COURT FINES AND FEES SCHEDULE - JANUARY 15, 2019

Pursuant to Section 15-1-6(4), of the Pueblo (Model) Traffic Code, the Presiding Municipal Judge shall at least annually review the schedule of designated fines of the Traffic Violations Bureau and adopt on or before January 15th of each year a schedule of designated fines for the Municipal Court.

In interests of justice, I feel it's also appropriate for the Presiding Municipal Judge to at least annually review the schedule of designated fines for all City of Pueblo Municipal Code Violations and adopt on or before January 15th of each year a schedule of designated fines for the Municipal Court.

The schedule of designated fines for the Municipal Court is presumptive in nature and has no impact on the inherent sentencing discretion of the Court within the limits of the City of Pueblo Municipal Code considering the unpredictable nature of mitigating and aggravating circumstances of individual cases.

The City of Pueblo Presiding Municipal Court Judge, Carla L. Sikes hereby adopts the attached Municipal Court Fines and Fees Schedule effective January 15, 2019.

2019 City of Pueblo MUNICIPAL COURT FINES AND FEES SCHEDULE (Effective January 15, 2019)

Pursuant to P.M.C. Sec. 1-2-1(b), Where no specific penalty is provided therefore, the violation of any provision of this Code or of any secondary code adopted herein shall be punished by a fine not exceeding one thousand dollars (\$1,000.00) or imprisonment for a term not exceeding one year or by both such fine and imprisonment, the amount of such fine or term of such imprisonment to rest within the discretion of the Municipal Judge. (Ord. 7937, 12-8-08)

As a result, the schedule of designated fines for the Municipal Court is presumptive in nature and has no impact on the inherent sentencing discretion of the Court within the limits of the City of Pueblo Municipal Code considering the unpredictable nature of mitigating and aggravating circumstances of individual cases.

Any cash bond posted may be forfeited or applied to fines and costs.

COURT APPEARANCES / COSTS AND FEES

Most Traffic Offense cases can be paid over the counter or by mail and without a court appearance except for six (6) point violations, eight (8) point violations, twelve (12) point violations, and any violation in which the issuing officer has specifically noted in the actual charge that the violation involves personal injury or appreciable property damage. Six (6) point violations, eight (8) point violations, twelve (12) point violations, and any violation in which the issuing officer has specifically noted in the actual charge that the violation involves personal injury or appreciable property damage will require a mandatory court appearance on the arraignment date (NOTE: The mandatory court appearance will not affect eligibility for deferred sentencing).

Absent a Court Order otherwise, the expectation is that Fines and Costs will be paid immediately.

A statutorily mandated “School Crossing Guard Surcharge” of \$10 is applied to all moving/point violations and a “School Crossing Guard Surcharge” of \$4 is applied to all parking violations.

A “Failure to Appear Warrant” (FTA) Fee of \$35 and “Contempt Warrant” (Contempt) Fee of \$100 is applied whenever a warrant is issued for FTA, or Contempt.

A Department of Motor Vehicles Outstanding Judgment Warrant Fee (OJW) / Administrative Processing Fee (APF) of \$30 is applied whenever a warrant is issued for any traffic offense, a default judgment has entered on a traffic infraction and whenever a warrant is issued in any case in which the defendant is a juvenile.

Failure to resolve a traffic infraction or parking ticket on or before the court date or otherwise appear for a court appearance, will result in default being entered and fine imposed. Any and all outstanding fines and fees may be sent to collections.

DEFERRED SENTENCING TRAFFIC MUNICIPAL ORDINANCE VIOLATIONS

A deferred sentence is a way you avoid a conviction on your record and avoid points being assessed against your driver’s license. It requires you to plead guilty or no contest to the charges and pay the fine and costs; however, the conviction and points are not reported to the Department of Motor Vehicles (and are not reported to your insurance company).

Deferred sentences are deferred for a period of up to twelve (12) months. If you are not adjudicated, convicted, or found guilty of any additional traffic offenses which occur after the plea date, and you pay the fine and costs, and you comply with any other conditions ordered by the Court, the conviction of a traffic offense will never enter and the case will be entered as dismissed in its entirety after the expiration of the deferred sentence period.

You are eligible for a deferred sentence if you have a clean driver history for the last three (3) years (including deferred sentences). There is an additional \$20 deferred sentence fee for a deferred sentence under these circumstances.

You are eligible for a deferred sentence if you have a relatively minor driver history for the last three (3) years ((no more than two (2) violations (including deferred sentences) with no more than a total point assessment of eight (8) points)). There is an additional \$50 deferred sentence fee for a deferred sentence under these circumstances.

You are not eligible for a deferred sentence if you have a previous deferred sentence still pending or any previous cases are in collections.

If you are under twenty-one (21) years of age on the date of offense, a condition of every deferred sentence will include a Traffic School.

If you are charged with any violation which carries six (6) points or more, you may be eligible for deferred sentencing; however, only after appearing in front of the Judge following an arraignment / advisement of rights session of court and making that specific request.

If your case is set for trial, you will not be given any further opportunity to receive the benefits of deferred sentencing.

Some specific offenses are not eligible for deferred sentencing under any circumstances.

To achieve consistency with regard to situations in which defendants on pending traffic deferred sentences are issued new traffic tickets, the following policy is implemented:

If a Defendant with a pending traffic deferred sentence is issued a new traffic ticket, the Defendant will have several options:

- (1) The Defendant may plead not guilty and set the matter for trial. If the Defendant is found not guilty, there will be no impact on the pending traffic deferred sentence. If the Defendant is found guilty, the Court may or may not revoke the pending traffic deferred sentence.
- (2) The Defendant may plead guilty or no contest (no deferred sentence), pay the standard fine, pay the costs, and the pending traffic deferred sentence will be revoked (conviction and points certified to D.M.V.).
- (3) The Defendant may plead guilty or no contest (no deferred sentence), pay twice the standard fine (up to \$1,000), pay the costs, and the pending traffic deferred sentence will not be revoked. NOTE: This option is available one (1) time during any pending deferred sentence.

As a result of this policy, the Court will apply a strict adherence to deferred sentencing dismissal dates.

Any deviations from this policy must be approved by the Court Administrator or the Judge.

Other Municipal Code Violations

All violations of International Property Maintenance Code require Mandatory Court.

NOTE: All Marijuana-related offenses, including the cultivation, use, or sale thereof, as set forth in Title XI, Chapters 10 and 11 and Title XVII, Chapter 15 require Mandatory Court.

Any Municipal Code violation (City Complaints) not specifically set forth herein requires Mandatory Court.

All “Other Municipal Code Violations (City Complaints)” that have a presumptive fine can be paid over the counter and without a court appearance on a first or second offense. Third or subsequent offenses and mandatory court appearance offenses require a mandatory court appearance.

COURT APPEARANCES / COSTS AND FEES

All Adult Police Regulation cases can be paid over the counter and without a court appearance on a first or second offence (except for mandatory court appearance related offenses). Third or subsequent offenses and mandatory court appearance related offenses require a mandatory court appearance.

All Juvenile Police Regulation cases require a mandatory court appearance. In addition, a parent or legal guardian must be present (NOTE: The mandatory court appearance will not affect eligibility for deferred sentencing). **Failure of a parent or guardian to appear for a mandatory court appearance may result in the issuance of a bench warrant for the parent or guardian.**

Absent a Court Order otherwise, the expectation is that Fines and Costs will be paid immediately.

A statutorily mandated “D.A.R.E.” Surcharge of \$5 applies to certain offenses, including: Disorderly Conduct, Possession of an Alcoholic Beverage, Menacing, Battery, Harassment, Substance Abuse, and Possession of Cannabis.

A statutorily mandated “Community Solid Waste Clean-up” Surcharge of \$50 applies to certain offenses, including every offense charged pursuant to Title 7, Chapter 3 - Solid Wastes of the Pueblo Municipal Code.

A statutorily mandated “Keep Pueblo Beautiful” Surcharge of \$25 applies to certain offenses, including all offenses charged pursuant to Title 7, Chapter 3 - Solid Wastes, Chapter 4 - Weeds, Chapter 5 - Fugitive Dust and Other Air Pollution Emissions, Title 11, Chapter 1, Sec. 204 - Littering, Sec. 607 - Noise, Chapter 4, Sec. 15 - Restraining, Sec. 22 - Crating and Cooping Fowls; Construction; Cleanliness, Sec. 23 - Manure; Accumulation; Disposition, Sec. 24 - Disposition of Animal Carcasses, Sec. 25 - Storage of Grain Feeds in Rodent-Proof Containers, Sec. 26 - Maiming; Abandoning; Rendering Aid, Sec. 27 - Picketing and Grazing Animals Forbidden, Sec. 28 - Driving or Herding Animals Forbidden, 31 - Keeping of Animals and Fowl Which Disturb Comfort, Peace, etc., of Neighborhood, Sec. 32 - Nuisances; Certain Fowl and Animals, Sec. 33 - Prohibited Animals, Sec. 43 – Licenses, Sec. 47 - Litter Permits, Sec. 48 - Sale in Public Places, Chapter 9, Sec. 3 - Prohibited Acts, Sec. 4 - Prohibition on Display and Sale, Title 17, Chapter 4, Sec. 21 - Visibility, Sec. 27 - Parking, Storage or Use of Major Recreational Equipment, and Sec. 28 - Parking and Storage of Certain Vehicles,

A statutorily mandated “Health Department Surcharge” of \$5 applies to all offenses charged pursuant to Title 7, Article 3.

A “Failure to Appear Warrant” (FTA) Fee of \$35 and “Contempt Warrant” (Contempt) Fee of \$100 is applied whenever a warrant is issued for FTA, and Contempt.

A Department of Motor Vehicles Outstanding Judgment Warrant Fee (OJW) / Administrative Processing Fee (APF) of \$30 is applied whenever a warrant is issued for any traffic offense or a default judgment enters on any traffic infraction; and whenever a warrant is issued in any case in which the defendant is a juvenile.

INCREASED PENALTIES FOR HABITUAL OFFENDERS

Anyone adjudged a Habitual Offender shall be punished as a Class 1 municipal offender with a fine not exceeding one thousand dollars (\$1,000.00) or imprisonment for a term not exceeding one (1) year, or by both such fine and imprisonment, the amount of the fine or term of imprisonment shall rest within the discretion of the Municipal Judge. You may be adjudged a Habitual Offender for all offenses except traffic infractions, if:

1. you have been previously convicted of the same offense twice, separately brought and adjudicated and arising out of separate distinct criminal episodes, within the previous five (5) years; or
2. you are charged with a crime of violence against a person or animal and have been previously convicted of the same or similar crime involving violence against another person or animal twice, separately brought and adjudicated and arising out of separate and distinct criminal episodes, within the previous ten (10) years.

Any person convicted of a crime and sentenced as a Habitual Offender for violations of Sections [11-4-14](#) (Vicious animals), [11-4-15](#) (Restraining), or [11-4-21](#) (Animals; cruelty to) may, at the discretion of the Municipal Court, be enjoined from owning any animals as defined by [Section 11-4-1](#) of the Pueblo Municipal Code, or otherwise maintaining any animals on their property within the City limits, along with any other appropriate penalty imposed by the Municipal Court.

DEFERRED SENTENCING - ADULT MUNICIPAL ORDINANCE VIOLATIONS

A deferred sentence is a way you avoid a conviction on your record. It requires you to plead guilty or no contest to the charges and pay the fine and costs; however, the conviction does not enter upon your record.

Deferred sentences are deferred for a period up to twelve (12) months. If you are not adjudicated, convicted, or found guilty of any additional criminal or delinquent offenses (excluding minor traffic offenses) which occur after the plea date, and you pay the fine and costs, and you comply with any other conditions ordered by the Court, the conviction will never enter and the case will be dismissed in its entirety.

You are eligible for a deferred sentence if you have no prior criminal convictions/adjudications of an identical nature within the last five (5) years and no other criminal convictions/adjudications (including deferred sentences) within the last three (3) years. There is an additional \$20 deferred sentence fee for a deferred sentence under these circumstances.

You are not eligible for a deferred sentence if you have a previous deferred sentence still pending (meaning you are still under the jurisdiction of the Court) or any previous cases are in collections.

If your case is set for trial, you will not be given any further opportunity to receive the benefits of deferred sentencing.

Some specific offenses are not eligible for deferred sentencing under any circumstances.

SEALING OF ADULT MUNICIPAL RECORDS OTHER THAN CONVICTIONS

A person may petition the Court to seal any arrest and criminal records. You must file a Petition to Seal and pay a filing fee of \$65. In order to qualify to have your records sealed, you must meet the following requirements:

- You were acquitted;
- You successfully completed a deferred sentence or deferred prosecution;
- Your case was dismissed;
- You have paid all outstanding restitution, fines, and fees;
- You have an arrest record, but you were not charged in court and the statute of limitations for the offense for which you were arrested that has the longest statute of limitations has run; or
- You have an arrest record, but you were not charged in court, the statute of limitations has not run, and you are no longer being investigated by law enforcement for commission of the offense. For information about specific statutes of limitations, see §16-5-401, C.R.S.

Records pertaining to traffic offenses and the offense of indecent exposure cannot be sealed.

DEFERRED SENTENCING - JUVENILE

MUNICIPAL ORDINANCE VIOLATIONS

(Non-traffic related)

A deferred sentence is a way you avoid a conviction on your record. It requires you to plead guilty or no contest to the charges and pay the fine and costs, however, the conviction does not enter upon your record.

Deferred sentences are deferred for a period up to twelve (12) months. If you are not adjudicated, convicted, or found guilty of any additional criminal or delinquent offenses (excluding minor traffic offenses) which occur after the plea date, and you pay the fine and costs, and you comply with any other conditions ordered by the Court, the conviction will never enter and the case will be dismissed in its entirety after completion of the deferred period.

You are eligible for a deferred sentence if you have no prior criminal convictions/adjudications of an identical nature within the last two (2) years and no other criminal convictions/adjudications (including deferred sentences) within the last one (1) year. There is an additional \$20 deferred sentence fee for a deferred sentence under these circumstances.

If you have a previous deferred sentence still pending (meaning you are still under the jurisdiction of the Court), you are not eligible for a deferred sentence.

If your case is set for trial, you will not be given any further opportunity to receive the benefits of deferred sentencing.

Some specific offenses are not eligible for deferred sentencing under any circumstances.

EXPUNGEMENT OF JUVENILE RECORDS

A juvenile may have the records in any criminal case expunged free of charge by order of this Court if:

- the case was dismissed;
- the juvenile fully complied with the sentence imposed and paid all outstanding restitution, fines, and fees; and
- the juvenile does not have any pending felony, misdemeanor, petty offense or delinquency actions.

Records pertaining to traffic offenses and the offense of indecent exposure cannot be expunged.
